




PRIVACY POLICY

1. General provisions

- 1.1 SAINT D LIMITED, 77 East Road, Studio Shoreditch Bsl, London, England, N1 6AH ("Saint D") Privacy Policy applies to all technical devices, websites, mobile applications, software solutions and other software that are operated and/or owned by Saint D ("Services").
- 1.2 For the purpose of providing smooth and efficient functioning of the www.saintdi.com website, "Saint D", the owner, can collect, process, use, store, transfer and reveal certain user data. 1.3 "Saint D's" business activities are under the sole control of "Saint D".
- 1.4 "Saint D" Privacy Policy is applied regardless of how Services are accessed.
- 1.5 You can ask "Saint D" at any time to provide you with the insight and access to your data within the reasonable time frame.
- 2. Personal data and data on entrepreneurs and companies
- 2.1 If you are using Services, there is a possibility that "Saint D" will collect and/or come in contact with the information on natural persons and legal entities, such as: name and surname/business name, address/registered office, e-mail, telephone number, company code, tax identification number, information from third-party plug-in "Calendly", as well as the information you provide and other publicly accessible information.
- 3. Data on using services
- 3.1 When it comes to using Services on your devices, there is a possibility that "Saint D" will collect and/or come in contact with information such as: device ID, cookies, location information, time and duration of using services, hardware and software model of the devices on which you are using services, email address, license key, session statistics, approximate geolocation, and browser, as well as the information you provide and other publicly accessible information.
- 3.2 "Saint D" collects and/or can come in contact with all other information that are publicly disclosed by the law, that are publicly available and/or published by you.
- 3.3 "Saint D" collects and/or can come in contact with information of public importance, with full protection of personal privacy rights in accordance with the laws in the England and Wales.
- 3.4 In accordance with the laws in the England and Wales, "Saint D" shall not collect particularly sensitive data referring to nationality, race, gender, language, religion, affiliation to a political party, union membership, health condition, receiving social welfare and criminal act conviction.
- 3.5 "Saint D" can perform analysis and collect reports about the work of the website.
- 3.6 Cookies Policy is a part of Privacy Policy. Website www.saintdi.com uses cookies, which are small files containing a string of characters that a website leaves on your hard drive so as to improve your internet search. You can choose to reject cookies from www.saintdi.com website at any time by





changing the settings on your computer and internet browser. In such case, there is a possibility you will not be able to access certain website parts.

4. Disclosure of data

- 4.1 We may disclose your data to "Saint D" employees, investors, related third parties and third parties that "Saint D" hires for business purposes.
- 4.2 We may disclose your data with state authorities and other legal entities in the event of insolvency, liquidation or bankruptcy of "Saint D", as well as in the event of status changes of "Saint D", in accordance with the laws in the England and Wales.
- 4.3 We may disclose your data in special circumstances if that is stipulated by the imperative legal provisions, and especially in the cases stipulated by the criminal laws in the England and Wales.
- 4.4 In the cases not covered by Privacy Policy and imperative legal provisions, we may disclose your data to other natural persons and legal entities at your request or in case you give consent.
- 4.5 Our services are not connected with the use of your social networks accounts, thus the connection and exchange of the data collected between the Services and such accounts is not part of Saint D's business model and Privacy Policy. As the user of such accounts on social media networks, you are obliged to get information from the social media network operators about every possible data exchange conducted in such way.
- 4.6 If you object to such data collection, validation, processing, knowing, accessing and/or using your data in accordance with Privacy Policy, please do not visit www.saintdi.com and do not use "Saint D's" Services.
- 5. Purpose of data usage
- 5.1 In accordance with Privacy Policy, "Saint D" can use users' data to:
- manage the Services;
- provide the guaranteed features of the Services you are using;
- address potential deficiencies and improvements according to your user needs, and provide the content supported by the Services;
- provide maintenance and support for the proper and reliable Service functioning;
- undertake preventive actions in potential cases of Service misuse or damage infliction to "Saint D";
- evaluate and analyze Services functionalities in order to optimize the work process and improve our Services daily.

6. Data protection

6.1 "Saint D" data protection implies cryptosecurity of the data, which implies cryptography and information management, in accordance with the norms and professional standards in the cryptosecurity area.

6.2 "Saint D" is conducting its business operations by using the technology that enables it, within its scope of business, to undertake formal and physical cryptography of the data collected, with the attention of a good expert in accordance with the laws in the England and Wales, and all with the purpose to protect the right to privacy and related rights and freedoms. 6.3 "Saint D" takes all the precautionary mechanisms to protect your data in accordance with the laws in the England and Wales. The requirements for collection and processing of personal data, the rights of persons and the protection of persons whose data are collected and processed, the protection restrictions, the procedure before the competent authority for protection, data security, records, transferring the data from the United Kingdom and supervision are regulated by the imperative provisions of the laws in the England and Wales. However, please note that no method of transmission over the internet or electronic storage is 100% secure.

7. Duration of data storage

7.1 "Saint D" will store your information only for the time period necessary for proper Services functioning, for the duration of the contract between you and "Saint D" and for the time period required by positive imperative regulations, after which the data will be deleted permanently.

8. Consent to international data transfer and user rights

8.1 By using the Services, you agree to international data transfer outside the United Kingdom, in accordance with Privacy Policy, other positive imperative regulations and ratified international conventions.

8.2 You have the right to:

- Access and obtain a copy of your personal information;
- Rectify any inaccurate or incomplete information;
- Erase your personal information under certain circumstances;
- Restrict or object to the processing of your personal information;
- Withdraw your consent at any time (if applicable);
- Lodge a complaint with the relevant data protection authority.
